#### SECOND OLBIIL ERA KELULAU

First Special Session, February 1985 RPPL NO. 2-1  
(Intro. as HB No. 2-0045-1, HD1, SD4)

#### AN ACT

To authorize and appropriate funds for obligation or expenditure to various budget activities in the form of a unified national budget for Fiscal Year 1985, and for related purposes.

THE PEOPLE OF PALAU REPRESENTED IN THE OLBIIL ERA KELULAU DO ENACT AS FOLLOWS:

Section 1. Appropriation. The sum of \$18,954,000 is authorized to be appropriated and is appropriated for expenditure or obligation in Fiscal Year 1985 from the National Treasury to the budget activities as set forth below:

## II. JUDICIARY \$450,000

The Chief Justice of the Supreme Court or his designee, at the commencement of each fiscal quarter, shall have the authority to withdraw not more than 25 percent of all funds appropriated pursuant to this Act, and may direct the Minister of Administration to establish a separate bank account outside of the National Treasury to be the depository of such funds. The Chief Justice or his designee shall have at his discretion the authority to solely administer, manage, and control all funds deposited in such bank account. All funds appropriated to the Judiciary shall be exempted from the provisions of Sections 10 and 12 of RPPL No. 1-16.
