

**[ REPUBLIC ACT NO. 1930, June 22, 1957 ]**

**AN ACT AMENDING CERTAIN SECTIONS OF REPUBLIC ACT  
NUMBERED ONE HUNDRED EIGHTY-THREE, OTHERWISE KNOWN  
AS THE CHARTER OF PASAY CITY, AS AMENDED.**

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

SECTION 1. The second paragraph of section seven of Republic Act Numbered One hundred eighty-three, as amended, is further amended to read as follows:

"He shall receive a salary of not exceeding nine thousand six hundred pesos a year. With the approval of the Municipal Board, the Mayor may be provided, in addition to his salary, a non-commutable allowance of not exceeding three thousand pesos *per annum*."

SEC. 2. Section eight of the same Act, as amended is further amended to read as follows:

"SEC. 8. *The Vice-Mayor*.—There shall be a Vice-Mayor who shall be elected in the same manner as the Mayor and shall at the time of his election possess the same qualifications as the Mayor. He shall receive a salary of not exceeding six thousand pesos a year. He shall act as Mayor and perform the duties and exercise the powers of the Mayor, in the event of sickness, absence, or other permanent or temporary incapacity of the Mayor and he shall, when occupying the position of the Mayor, be entitled to the salary and allowances of the Mayor."

SEC. 3. The first paragraph of section eleven of the same Act, as amended is further amended to read as follows:

"SEC. 11. *Secretary to Mayor*.—The Mayor shall appoint one secretary who shall hold office at the pleasure of the Mayor and who shall receive a compensation not exceeding four thousand eight hundred pesos *per annum*."

SEC. 4. The last paragraph of section twelve of the same Act, as amended is further amended to read as follows:

"The members of the Municipal Board shall receive a compensation of four thousand eight hundred pesos each *per annum*."

SEC. 5. The first paragraph of section fourteen of the same Act is amended to read as follows:

"SEC. 14. *Appointment, salary and duties of Secretary of Board*.—The Board shall have a secretary who shall be appointed by it to serve during

the term of office of the members thereof. The secretary of the Board shall receive a salary of not exceeding four thousand eight hundred pesos *per annum*. A vacancy in the office of the secretary shall be filled temporarily for the unexpired term in like manner."

SEC. 6. The first paragraph of section twenty of the same Act, as amended is further amended to read as follows:

"SEC. 20. *Appointment and removal of officials and employees.*—The President of the Philippines shall appoint, with the consent of the Commission on Appointments, two judges and two auxiliary judges of the municipal court, the city treasurer, the city engineer, the city attorney, and the assistant city attorneys, the city health officer, the chief of police, the city assessor, the chief of the fire department, and the other heads of such city departments as may be created. Except the judges, the auxiliary judges of the municipal court, the city attorney and the assistant city attorneys, said officers shall hold office at the pleasure of the President, unless sooner removed for cause."

SEC. 7. The first paragraph of section twenty-two of the same Act, as amended is further amended to read as follows:

"SEC. 22. *The City Treasurer—His powers, duties and compensation.*—There shall be a city treasurer, who shall have charge of the department of finance and shall act as chief fiscal officer and financial adviser of the city and custodian of its funds. He shall receive a salary of eight thousand four hundred pesos *per annum*. There shall also be an assistant city treasurer who shall receive a salary of five thousand four hundred pesos *per annum*. He shall perform the duties and exercise the powers of the city treasurer in the event of sickness, absence or other temporary incapacity of the city treasurer. The city treasurer shall have the following general powers and duties:"

SEC. 8. The first paragraph of section twenty-three of the same Act, as amended is further amended to read as follows:

"SEC. 23. *The City Engineer—His powers, duties and compensation.*—There shall be a city engineer, who shall be in charge of the Department of Engineering and Public Works. He shall receive a salary of eight thousand four hundred pesos per annum. There shall also be an assistant city engineer who shall receive a salary of five thousand four hundred pesos per annum. He shall perform the duties and exercise the powers of the city engineer, in the event of sickness, absence or other temporary incapacity of the city engineer. The city engineer shall have the following powers and duties:"

SEC. 9. Section twenty-six of the same Act, as amended is further amended to read as follows:

"SEC. 26. *Compensation of City Attorney and his Assistants.*—The city attorney and his assistants shall receive the salaries hereinafter set forth, which shall be paid by Pasay City:
