

# [ EXECUTIVE ORDER NO. 225, December 13, 1965 ]

## MODIFYING THE RATES OF IMPORT DUTY OF CERTAIN IMPORTED ARTICLES AS PROVIDED UNDER REPUBLIC ACT NUMBERED NINETEEN HUNDRED THIRTY-SEVEN, OTHERWISE KNOWN AS THE TARIFF AND CUSTOMS CODE OF THE PHILIPPINES AS AMENDED.

Pursuant to the powers vested in me by Section 401 of Republic Act Number Nineteen Hundred Thirty-seven, I, Diosdado Macapagal, President of the Philippines, do hereby direct and order:

SECTION 1. The articles specifically listed hereunder as classified under Section 104 of Republic Act Number Nineteen Hundred Thirty-seven shall pay the following rates of import duty:
