**AMENDING THE REVISED SCHEDULE OF FEES AND CHARGES FOR  
THE SERVICES RENDERED BY THE LABORATORY SERVICES  
DIVISION OF THE BUREAU OF ANIMAL INDUSTRY**

Pursuant to Executive Order No. 197 directing all Departments, Bureaus, Commissions, Agencies, Offices and Instrumentalities of the National Government including government-owned or controlled corporations to increase rates of fees and charges by not less than 20 percent, the following shall be imposed by the Laboratory Services Division of the Bureau of Animal Industry for services rendered.
