May 31, 1994 ]**

**AMENDMENT NO. 1 TO RULES IMPLEMENTING THE CODE OF  
CONDUCT AND ETHICAL STANDARDS FOR PUBLIC OFFICIALS  
AND EMPLOYEES**

To insure a uniform implementation of the provisions of Section 8 of Republic Act No. 6713, otherwise known as the "Code of Conduct and Ethical Standards for Public Officials and Employees", Section 1 (c), (d) and (f), RULE VII, PUBLIC DISCLOSURE of the implementing RULES are hereby amended, to read as follows:

(c) *Where to File* — The Statement of Assets, Liabilities and Network and the Disclosure of Business Interest and Financial Connections shall be filed by OFFICIALS AND EMPLOYEES at the Offices indicated opposite their positions:
