CREATING AND DESIGNATING SEVERAL PARCELS OF LAND LOCATED ALONG BARANGAY DOLORES AND BANABA, PORAC, PAMPANGA, AS A SPECIAL ECONOMIC ZONE, PURSUANT TO REPUBLIC ACT NO. 7916, AS AMENDED BY REPUBLIC ACT NO. 8748
