PROCLAMATION NO. 492 AMENDING PROCLAMATION NO. 16, DATED APRIL 27, 1922 WHICH ESTABLISHED THE CAVE FOREST RESERVATION ON A PARCEL OF LAND OF THE PUBLIC DOMAIN SITUATED IN CRYSTAL CAVE, CITY OF BAGUIO, ISLAND OF LUZON, BY EXCLUDING A CERTAIN PORTION OF THE LAND ENBRACED THEREIN AND DECLARING THE SAME FOR EDUCATIONAL PURPOSES

Upon recommendation of the Secretary of Environment and Natural Resources and by virtue of the powers vested in me by law, **I, GLORIA MACAPAGAL-ARROYO**, President of the Republic of the Philippines, do hereby amend Proclamation No. 16 dated April 27, 1922, which established the Cave Forest Reservation on a parcel of land located in Crystal Cave, City of Baguio Island of Luzon by excluding a certain portion of the land embraced therein and declaring the same for educational use of the Bakakeng Central Barangay, which excluded parcel is more particularly described as follows:

SWO-CAR-000683 Bakakeng Central Barangay

A parcel of land (SWO-CAR-000683) situated at Rurban Code 131102, Res. Sec. "E", City of Baguio, Island of Luzon.

Bounded on the NE.; along line 1-2 by Lot 113; MN-81 (portion) the Cave Forest Reservation; on the SE.; along line 2-3-4-5-6 and on the SW., along lines 6-7-8-9-10 and on the W., along lines 11-12-13-1 by Lot No. 113, MN-81 (portion), the Cave Forest Reservation.
