## [PROCLAMATION NO. 81, February 12, 1963]

## EXCLUDING FROM THE OPERATION OF PROCLAMATION NO. 423, DATED JULY 12, 1957, WHICH ESTABLISHED THE MILITARY RESERVATION OTHERWISE KNOWN AS FORT WILLIAM MCKINLEY, A CERTAIN PORTION OF LAND EMBRACED THEREIN, LOCATED IN THE MUNICIPALITIES OF TAGUIG AND PARAÑAQUE, PROVINCE OF RIZAL, AND IN PASAY CITY, ISLAND OF LUZON, AND RESERVING THE SAME FOR WORKERS' UNIVERSITY SITE PURPOSES

Upon the recommendation of the Secretary of Agriculture and Natural Resources and pursuant to the authority vested in me by law, I, Diosdado Macapagal, President of the Philippines, do hereby exclude from the operation of Proclamation No. 423, dated July 12, 1957, which established the military reservation otherwise known as Fort William Mckinley, a certain portion of land embraced therein, located in the Municipalities of Taguig and Parañaque, Province of Rizal, and in Pasay City, Island of Luzon, and reserve the same for Workers' University site purposes under the administration of the Secretary of Education, subject to private rights, if any there be, and to final survey, which portion of land is more particularly described as follows:
