

[PROCLAMATION NO. 131, July 09, 1963]

**RESERVING FOR BUILDING SITE PURPOSES OF THE LOS BAÑOS
SCHOOL OF FISHERIES CERTAIN PARCELS OF LAND OF THE
PUBLIC DOMAIN SITUATED IN THE BARRIO OF MAYONDON,
MUNICIPALITY OF LOS BAÑOS, PROVINCE OF LAGUNA, ISLAND
OF LUZON**

Upon the recommendation of the Secretary of Agriculture and Natural Resources and pursuant to the authority vested in me by law, I Diosdado Macapagal, President of the Philippines, do hereby withdraw from sale or settlement and reserve for building site purposes of the Los Baños School of Fisheries under the administration of the Director of Public Schools, subject to private rights, if any there be, the following parcels of land of the public domain, situated in the barrio of Mayondon, municipality of Los Baños , province of Laguna, Island of Luzon, and more particularly described as follows:

Lot I Nr-132-D
(Republic of the Philippines
School of Fisheries)

A parcel of land (Lot 1 of plan Nr-132-D, L. R. C. Record No, —), situated in the Barrio of Mayondon, Municipality of Los Baños, Province of Laguna. Bounded on the SE., along line 1-2, by property of Heirs of Manuel Gibas; and on the SW., NW., and NE., along lines 2-3-4-1, by Lot 2 of plan Nr-132-D. Beginning at a point marked 1 on plan, being N. 60° 44' E., 1,967.35 meters from B.L.L.M. 2, Los Baños, Laguna, thence S. 36° 50' W., 102.38 meters to point 2; thence N. 60° 00' W., 50.00 meters to point 3; thence N. 22° 33' E., 89.83 meters to point 4; thence S. 69° 40' E., 74.90 meters to the point of beginning; containing an area of 5,903 square meters.
