

**[ PROCLAMATION NO. 405, April 04, 1957 ]**

**AMENDING PROCLAMATION NO. 267, DATED FEBRUARY 27, 1956, WHICH RESERVED AMONG OTHERS, A CERTAIN PARCEL OF LAND SITUATED IN THE MUNICIPALITY OF SAN JOSE, PROVINCE OF MINDORO OCCIDENTAL, ISLAND OF MINDORO, FOR PUERICULTURE CENTER SITE PURPOSES BY REDUCING THE AREA RESERVED FOR THE PURPOSE TO 1,000 SQUARE METERS AND DECLARING THE REMAINING PORTION OPEN TO DISPOSITION UNDER THE PROVISIONS OF THE PUBLIC LAND ACT**

Upon the recommendation of the Secretary of Agriculture and Natural Resources and pursuant to the provisions of sections 83 and 88 of Commonwealth Act No. 141, as amended, I, Carlos P. Garcia, President of the Philippines, do hereby amend Proclamation No. 267, dated February 27, 1956, which reserved, among others, a certain parcel of land situated in the municipality of San Jose, province of Mindoro Occidental, island of Mindoro, for puericulture center site purposes by reducing the area reserved for the purpose, to 1,000 square meters and declaring the remaining portion open to disposition under the provisions of the; said Act and which area as reduced is more particularly described as follows:

*Lot 3-H*  
(Puericulture Center)

A parcel of land (lot 3-H of the proposed amendment plan, being a portion of lot 3 described on plan Swo-37916), situated in the municipality of San Jose, province of Mindoro Occidental, island of Mindoro. Bounded on the N., along line 1-2, by lot 3-B of the amendment plan; along lines 2-4, by lot 3-B of the amendment plan; and along lines 4-1, by Narra Street. Beginning at a point marked 1 on plan, being S. 58° 03' W., 256.34 meters from B.L.L.M. 65, municipality of San Jose, Mindoro Occidental, thence N. 80° 58' E., 45.85 meters to point 2; thence S. 9° 02' E., 21.89 meters to point 3; thence S. 80° 58' W., 45.51 meters to point 4; thence N. 9° 55' W., 21.89 meters to the point of beginning; containing an approximate area of 1,000 square meters.

NOTE: Data used are subject to change for future survey.
