

[PROCLAMATION NO. 445, December 23, 1953]

RESERVING FOR RELOCATION CENTER PURPOSES CERTAIN PARCELS OF THE PRIVATE DOMAIN OF THE GOVERNMENT SITUATED IN THE DISTRICT OF DILIMAN, QUEZON CITY

Upon the recommendation of the Secretary of Agriculture and Natural Resources and pursuant to the provisions of Section 64(e) of the Revised Administrative Code, I hereby withdraw from sale or settlement and reserve for relocation center purposes under the sponsorship of the Philippine Council for United States Aid, the Mutual Security Agency of the United States Government and the Slum Clearance Committee in connection with the slum clearance Program for the City of Manila, subject to private rights, if any there be, certain parcels of the private domain of the Government situated in the District of Diliman, Quezon City, and more particularly described as follows, to wit:

“A PARCEL OF LAND (Lot R.P. 3-B-4-B-4 of Diliman Estate Subdivision plan Bsd-10532, being a portion of Lot R.P. 3-B-4-B of plan Bsd-10352, G.L.R.O Record No. 7681), situated in the District of Diliman, Quezon City. Bounded on the NS., by Culiati Creek; on the SE., by R.P. 3-B-4-B-5 and Lot R.P. 3-B-4-B-2 of the subdivision plan; on the SE., by Lot R.P. 3-B-4-B-2 and Lot R.P. 3-B-4-B-3 of the subdivision plan; and on the W. and NW., by Culiati Creek. Beginning at a point marked “1” on plan, being N. 31 deg. 08' W., 2442.35 m. more or less from B.L.L.M. No. 7, Quezon City,
