## [ PROCLAMATION NO. 330, July 15, 1952 ]

## RESERVING FOR SCENIC PARK AND RECREATION PURPOSES CERTAIN PARCELS OF THE PUBLIC DOMAIN SITUATED IN THE MUNICIPALITY OF ANTIPOLO, PROVINCE OF RIZAL, ISLAND OF LUZON.
