

[PROCLAMATION NO. 143, September 28, 1949]

**RESERVING FOR HIGH SCHOOL SITE PURPOSES A CERTAIN
PARCEL OF THE PUBLIC DOMAIN SITUATED IN THE
MUNICIPALITY OF CAUAYAN, PROVINCE OF ISABELA, ISLAND
OF LUZON**

Upon the recommendation of the Secretary of Agriculture and Natural Resources, and pursuant to the provisions of section 83 of Commonwealth Act No. 141, as amended, I hereby withdraw from sale or settlement and reserve for High School site purposes, under the administration of the Director of Public Schools, subject to private rights, if any there be, a certain parcel of the public domain situated in the municipality of Cauayan, Province of Isabela, Island of Luzon, and more particularly described in the Bureau of Lands plan Psu-119942, to wit:

Psu-119942

The Municipal Government of Cauayan

"A parcel of land (Plan Psu-119942, G.L.R.O. Record No. _____), situated in the poblacion, municipality of Cauayan, Province of Isabela. Bounded on the north by property of the Municipal Gov't. of Cauayan (lot "A", Psd-24238); on the northeast by property of Cleopatra Ordonez; on the southeast by properties of the Municipal Gov't. of Cauayan (lot "A". Psd-24238) and Nieves Tolentino; on the southwest, by National Highway; and on the northwest, by properties of Laureano Lucas and Cleopatra Ordonez. Beginning at a point marked "1" on plan, being N. 41° 56' W., 1335.82 from B.L.L.M. 1, Mp. of Cauayan — thence S. 19° 31' W., 193.39 m. to point "2"; thence S. 19° 15' W., 192.00 m. to point "3"; thence S. 86° 04' E., 101.28 m. to point "4"; thence S. 17° 46' W., 194.98 m. to point "5"; thence S. 17° 46' W., 194.98 m. to point "6"; thence N. 77° 35' W., 152.16 m. to point "7"; thence N. 18° 33' W., 200.00 m. to point "8"; thence N. 18° 35' E., 200.00 m. to point "9"; thence N. 18° 32' E., 165.33 m. to point "10"; thence N. 19° 23' E., 249.24 m. to point "11"; thence S. 70° 07' E., 49.97 m. to point "12"; thence S. 18° 37' W., 47.37 m. to the point of beginning, containing an area of seventy-eight thousand two hundred seventy-four square meters (78,274), more or less. All points referred to are indicated on the plan and are marked on the grounds as follows: point "1", by Old P.L.S. conc. monument; points "2" and "3" by old B.L. Conc. monuments; and the rest, by P.L.S. cyl. conc. monuments; bearings true; declination 0° 22' E., date of the survey, June 11, 1948 and that of the approval of Aug. 18, 1948."
