

**[ PROCLAMATION NO. 374, March 10, 1953 ]**

**RESERVING FOR THE USE OF THE ECONOMIC DEVELOPMENT CORPS (EDCOR) A CERTAIN PARCEL OF THE PUBLIC DOMAIN SITUATED IN THE MUNICIPALITY OF AGLIPAY, PROVINCE OF NUEVA VIZCAYA, ISLAND OF LUZON.**

Upon the recommendation of the Secretary of Agriculture and Natural Resources, and pursuant to the provisions of section 83 of Commonwealth Act No. 141, as amended, I hereby withdraw from sale and settlement and reserve for the use of the Economic Development Corps (EDCOR) under the administration of the Armed Forces of the Philippines, subject to private rights, if any there be, and to the condition that the timber and other forest products therein shall remain under the administrative control of the Bureau of Forestry, in accordance with the Forest Law and Regulations, the following parcel of the public domain, situated in the municipality of Aglipay, Province of Nueva Vizcaya, Island of Luzon, to wit:

Beginning at point 1 which is N. 48° E., about 2,900 meters from sitio Angat, municipality of Aglipay, Nueva Vizcaya; thence following Ditabuan. Creek upstream in a southeasterly direction about 2,880 meters to corner 2, a Lingolingo tree 40 centimeters in diameter; thence following the same creek upstream in an easterly direction about 440 meters to corner 3, a miscellaneous species tree 10 centimeters in diameter; thence following Dinifung Creek upstream in a general southwesterly direction about 2,550 meters to corner 4, a Pahutan tree 25 centimeters in diameter; thence following the same creek upstream in a general southwesterly direction about 1,700 meters to corner 5, a Cañafistula tree 40 centimeters in diameter; thence following the same creek upstream in a general southeasterly direction about 920 meters to corner 6, a miscellaneous species tree 20 centimeters in diameter; thence following the same creek upstream in a general southeasterly direction about 700 meters to corner 7, a Lauan tree 30 centimeters in diameter; thence following the same creek upstream in a general southwesterly direction about 780 meters to corner 8, an .Eugenia species tree 30 centimeters in diameter; thence S. 66° W., about 450 meters to corner 9, a miscellaneous species tree 40 centimeters in diameter; thence S. 06° W., about 380 meters to corner 10, a miscellaneous species tree 30 centimeters in diameter; thence S. 18° W., about 320 meters to corner 11, an Apitong tree 50 centimeters in diameter; thence S. 46° W., about 220 meters to corner 12, a miscellaneous species tree 120 centimeters in diameter; thence N. 75° W. about 170 meters to corner 13, a miscellaneous species tree 60 centimeters in diameter; thence S. 50° W., about 420 meters to corner 14, a Bitanhol tree 30 centimeters in diameter, thence S. 50° W., about 200 meters to corner 15, a Magabuyo tree 40 centimeters in diameter; thence S. 87° W., about 220 meters to corner 16, a Magabuyo tree 25 centimeters in diameter; thence N. 44° W., about 150 meters to corner 17, an Apitong tree 60 centimeters in diameter; thence N. 81° W. about 250 meters to corner 18, a Narra tree 50 centimeters in diameter; thence N. 44° W. about 300 meters to corner 19, Eugenia species tree 40
