# [ Act No. 2319, January 31, 1914 ]

# AN ACT APPROPRIATING FUNDS FOR SUNDRY EXPENSES OF THE INSULAR GOVERNMENT FOR THE FISCAL YEAR ENDING DECEMBER THIRTY-FIRST, NINETEEN HUNDRED AND FOURTEEN, AND FOR OTHER PURPOSES.

By authority of the United States, be it enacted by the Philippine Legislature, that:

SECTION 1. The following sums, or so much thereof as may be respectively necessary, are hereby appropriated, out of any funds in the Insular Treasury not otherwise appropriated, in compensation for the service of the Insular Government for the fiscal year ending December thirty-first, nineteen hundred and fourteen, unless otherwise stated.
