# [ Act No. 201, August 13, 1901 ]

AN ACT APPROPRIATING TWENTY-SEVEN THOUSAND AND FORTY-THREE DOLLARS AND THIRTY-TWO CENTS, OR SO MUCH THEREOF AS MAY BE NECESSARY, IN MONEY OF THE UNITED STATES, TO PAY VARIOUS EXPENSES OF THE INSULAR GOVERNMENT FOR THE THIRD QUARTER OF THE YEAR NINETEEN HUNDRED AND ONE AND OTHER DESIGNATED PERIODS NOT PROVIDED FOR IN THE GENERAL APPROPRIATION ACT FOR THE THIRD QUARTER.

By authority of the President of the United States, be it enacted by the United States Philippine Commission, that:

SECTION 1. The sum of twenty-seven thousand and forty-three dollars and thirty-two cents, or so much thereof as may be necessary, in money of the United States, is hereby appropriated, out of any money in the Insular Treasury not otherwise appropriated, to pay the following expenses of the Insular Government for the third quarter of the year nineteen hundred and one and other designated periods:

### GENERAL SUPERINTENDENT OF PUBLIC INSTRUCTION.

For ten thousand Visayan-English primers, three thousand dollars; forty-nine thousand eight hundred and fifty-five Spanish-English histories, one thousand eight hundred and forty-four dollars and sixty-four cents; ten Webster's International Dictionaries, eighty-one dollars; ten Webster's Collegiate Dictionaries, thirty dollars; ten magic lanterns, four hundred dollars; office supplies, printing, and stationery, ten thousand dollars.

In all, for the General Superintendent of Public Instruction, fifteen thousand three hundred and fifty-five dollars and sixty-four cents, or so much thereof as may be necessary.

# QUARTERMASTER UNITED STATES MILITARY PRISON, BACOLOR.

For the salary of one ex-volunteer captain, retained after the expiration of his service by resolution of the Commission, from July first to July eleventh, sixty dollars and fifty cents; one ex-volunteer lieutenant, retained after expiration of his service by resolution of the Commission, from July first to July thirty-first, one hundred and twenty-eight dollars and thirty-three cents; purchase of mineral oil for August and September, thirty-seven dollars and fifty cents.

In all, for the quartermaster United States Military Prison, Bacolor, two hundred and twenty-six dollars and thirty-three cents, or so much thereof as may be necessary.

## DEPARTMENT OF PRISONS.

For salaries of one warden at two thousand four hundred dollars per annum, and one assistant warden at one thousand eight hundred dollars per annum, from August ninth to September thirtieth, nineteen hundred and one, six hundred and thirteen dollars and thirty-three cents. For cleaning cesspools and dry-earth closets,

one thousand seven hundred dollars.

In all, for the Department of Prisons, two thousand three hundred and thirteen dollars and thirty-three cents, or so much thereof as may be necessary.

### PROVINCIAL GOVERNMENT OF CEBU.

For maintenance of a leper colony in the Province of Cebu for July, August, and September, one thousand one hundred and fifty-nine dollars and twenty cents, or so much thereof as may be necessary.

### BOARD OF HEALTH FOR THE PHILIPPINES.

For subsistence of patients in the smallpox hospital, plague hospital, and San Lazaro Hospital, eight hundred dollars, or so much thereof as may be necessary.

# MISCELLANEOUS EXPENSES.

For cleaning closets at civil police stations for the month of June, in the Department of Streets, Parks, Fire, and Sanitation, under the Provost-Marshal-General, eight hundred and eighty-nine dollars and sixty cents, or so much thereof as may be necessary.

For salaries from July first to August seventh, nineteen hundred and one, in Medico-Legal Department, as follows: Two physicians at fifty dollars per month each; two practicantes at fifteen dollars per month each; one concierge at fifteen dollars per month; and one servant at five dollars per month; total of salaries, one hundred and eighty-five dollars, or so much thereof as may be necessary.

For salaries for the month of July, hereby authorized, of four assistant prosecutors of the Courts of First Instance of Manila, who performed actual services without formal authorization of law, four hundred and fifty dollars.

For F. M. Kiggins, for allowance in lien of salary for earned leave of absence, three hundred and fifty dollars.

For the following expenses incurred in the office of the quartermaster, Provost-Marshal-General, prior to July first, nineteen hundred and one: Rent of civil police barracks, number four Calle Gunao, Quiapo, March first to March thirty-first, one hundred and thirty-seven dollars and fifty cents; rent of quarters for two officers performing services under the Provost-Marshal-General prior to March thirty-first, nineteen hundred and one, ninety-three dollars and sixty cents; rent of market site on Calle Real, Paco, from October, eighteen hundred and ninety-eight, to June thirtieth, nineteen hundred and one, twenty-seven dollars: for repairs to and hire of transportation for officers of the city government for June, three hundred and ninety-five dollars and ninety-five cents; forage for native ponies for the city government for month of June, one hundred and thirty-seven dollars and ten cents.

For expenses incurred in the office of the quartermaster, Provost-Marshal-General, from July first to August seventh, as follows: Cleaning cesspools and dry-earth closets in schools, police and fire stations, one thousand dollars; forage and shoeing for native ponies of the city government, five hundred dollars; hire of transportation
