PART 1

PRELIMINARY

Short title and commencement

- 1.—(1) This Act is the Small Motorised Vehicles (Safety) Act 2020.
- (2) Paragraph (c) of the definition of "personal mobility device" or "PMD" in section 2(1) and paragraph (c) of the definition of "power-assisted bicycle" or "PAB" in section 2(1) and section 29(e) come into operation on a date that the Minister appoints by notification in the *Gazette*.

Interpretation

- **2.**—(1) In this Act, unless the context otherwise requires
 - "authorised officer", for any provision of this Act, means an individual who is appointed under section 17 as an authorised officer for the purposes of that provision;
 - "Authority" means the Land Transport Authority of Singapore constituted under the Land Transport Authority of Singapore Act 1995;
 - "conveyance" includes any vessel, train, vehicle or aircraft in which persons or goods can be carried;
 - "customs territory" means any part of Singapore and her territorial waters but excludes any free trade zone;
 - "export", in relation to any goods, means
 - (a) to take or cause to be taken out of the customs territory by land, water or air to any place, including a free trade zone; or
