## HOUSING AND DEVELOPMENT (PRECINCTS FOR LIFT UPGRADING WORKS) (NO. 14) ORDER 2010

In exercise of the powers conferred by section 65B(1) of the Housing and Development Act, the Minister for National Development, after consulting the Housing and Development Board, hereby makes the following Order:

#### Citation and commencement

1. This Order may be cited as the Housing and Development (Precincts for Lift Upgrading Works) (No. 14) Order 2010 and shall come into operation on 31st August 2010.

### **Declaration of precincts for lift upgrading works**


2. The parts of the housing estates of the Board described in the Schedule are hereby declared to be precincts for the purpose of carrying out lift upgrading works.



All that part of the housing estate of the Board at Ang Mo Kio Avenue 1/3 comprised in Lot numbers 12007V, 12008P, 06707K, 06708N, 06987W, 06988V, 06989P, 12115T and 06990W in Mukim 18 and on which Apartment Blocks 221, 222, 229, 230, 231, 232, 233, 234 and 235 are erected, and which is more particularly delineated in Plan 1.





2. All that part of the housing estate of the Board at Ang Mo Kio Avenue 3 comprised in Lot numbers 16524W, 16525V, 16526P, 16509P, 16527T, 16528A, 16529K and 16530T in Mukim 18 and on which Apartment Blocks 301, 302, 322, 323, 324, 325, 326 and 327 are erected, and which is more particularly delineated in Plan 2.


## PLAN 2 ANG MO KIO AVENUE 3
