In exercise of the powers conferred by section 65B(1) of the Housing and Development Act, the Minister for National Development, after consulting the Housing and Development Board, hereby makes the following Order:

Citation and commencement

1. This Order may be cited as the Housing and Development (Precincts for Lift Upgrading Works) (No. 4) Order 2010 and shall come into operation on 3rd March 2010.

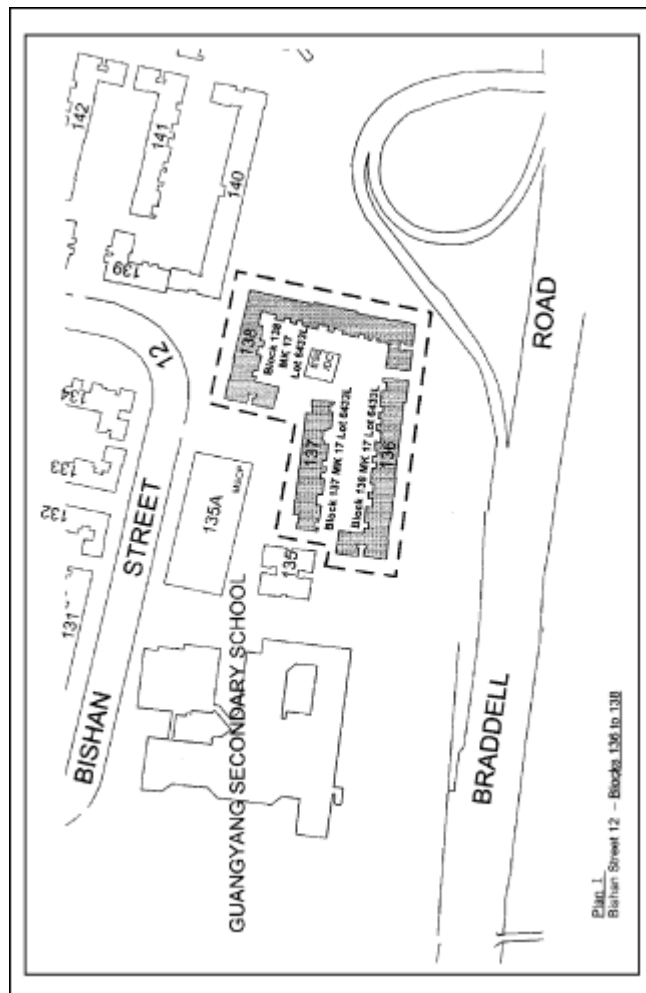
Declaration of precincts for lift upgrading works

2. The parts of the housing estates of the Board described in the Schedule are hereby declared to be precincts for the purpose of carrying out lift upgrading works.

THE SCHEDULE

1. All that part of the housing estate of the Board at Bishan Street 12 comprised in Lot number 6433L in Mukim 17 and on which Apartment Blocks 136, 137 and 138 are erected, and which is more particularly delineated in Plan 1.

2. All that part of the housing estate of the Board at Clementi Avenue 2/5 comprised in Lot numbers 1340X, 1339C, 1341L and 1342C in Mukim 3 and on which Apartment Blocks 362, 363, 364 and 365 are erected, and in Lot numbers 3389C, 3392C, 3393M, 3394W, 3239M, 3238C, 3240L, 3370A, 3371K, 3350V and 3351P in Mukim 5 and on which Apartment Blocks 343, 346, 347, 348, 349, 350, 351, 352, 354, 358 and 359 are erected, and which is more particularly delineated in Plan 2.

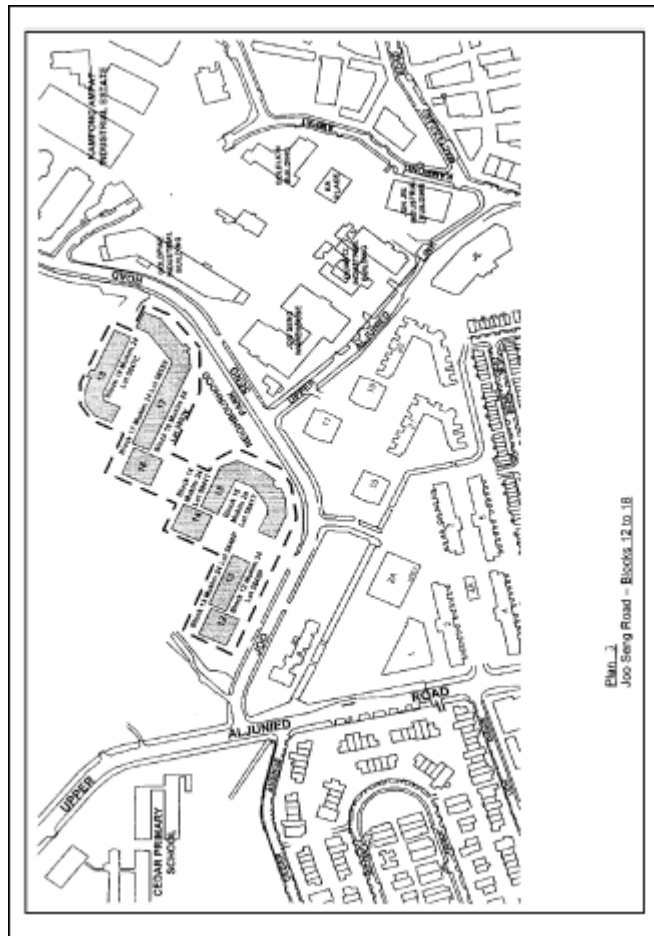
PLAN 2 CLEMENTI AVENUE 2/5

All that part of the housing estate of the Board at Joo Seng Road comprised in Lot number 5840P in Mukim 24 and on which Apartment Blocks 12 and 13 are erected, in Lot number 5841T in Mukim 24 and on which Apartment Blocks 14 and 15 are erected, in Lot number 5853V in Mukim 24 and on which Apartment Blocks 16 and 17 are erected, and in Lot number 5847C in Mukim 24 and on which Apartment Block 18 is erected, and which is more particularly delineated in Plan 3.
