In exercise of the powers conferred by section 65B(1) of the Housing and Development Act, the Minister for National Development, after consulting the Housing and Development Board, hereby makes the following Order:

Citation and commencement

1. This Order may be cited as the Housing and Development (Precincts for Lift Upgrading Works) Order 2011 and shall come into operation on 7th January 2011.


Declaration of precincts for lift upgrading works

2. The parts of the housing estates of the Board described in the Schedule are hereby declared to be precincts for the purpose of carrying out lift upgrading works.

1. All that part of the housing estate of the Board at Balam Road comprised in Lot number 06045X in Mukim 24 and on which Apartment Block 31 is erected, and which is more particularly delineated in Plan 1.


PLAN 1 BALAM ROAD

PLAN 2


BEDOK NORTH AVENUE 1


BEDOK NORTH STREET 3
