**1.** This Order may be cited as the Housing and Development (Precincts for Upgrading Works) (Consolidation) Order.


## **Precincts for upgrading works**

1. All that part of Farrer Road housing estate of the Board comprised in Lot numbers 1724, 1217, 1218, 1726, 1220 and 1551 in Mukim 2 and on which Apartment Blocks 1 to 6 and 8 are erected, and which is more particularly delineated in Plan 1.


### PLAN 1 FARRER ROAD


## PLAN 2 PAYA LEBAR


erected, and which is more particularly delineated in Plan 3.
