In exercise of the powers conferred by section 65B(1) of the Housing and Development Act, the Minister for National Development, after consulting the Housing and Development Board, makes the following Order:

Citation and commencement

1. This Order is the Housing and Development (Precincts for Upgrading Works) (Home Improvement Programme) (No. 6) Order 2016 and comes into operation on 19 September 2016.

Declaration of precincts for Home Improvement Programme

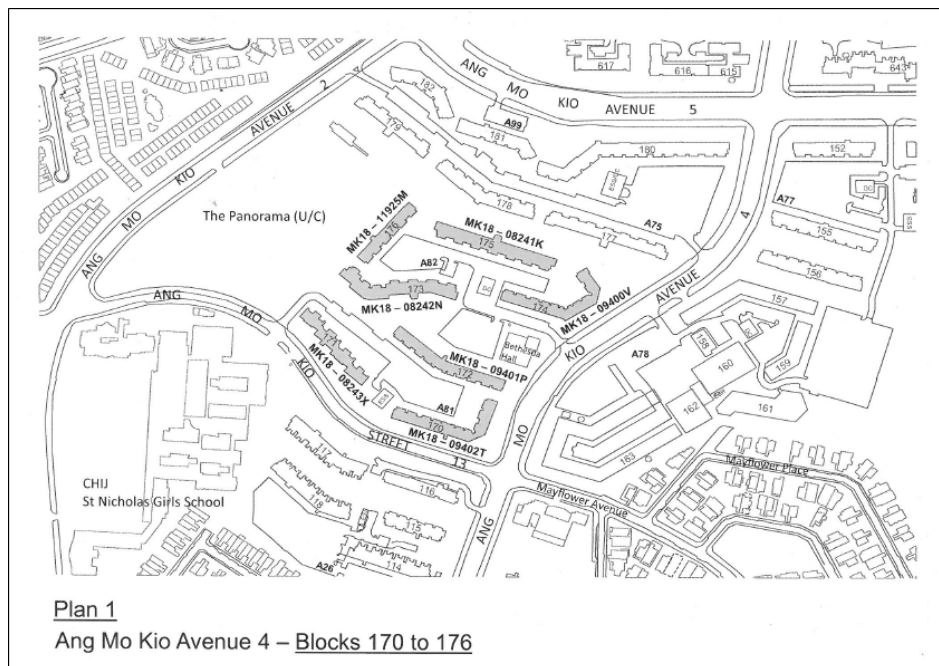
2. The parts of the housing estates of the Board described in the Schedule are declared to be precincts for the purpose of carrying out upgrading works in connection with the Home Improvement Programme.

THE SCHEDULE

1. All that part of the housing estate of the Board bounded by Ang Mo Kio Street 13 and Ang Mo Kio Avenue 4, comprised in Lot numbers 09402T, 08243X, 09401P, 08242N, 09400V, 08241K and 11925M in Mukim 18 and on which Apartment Blocks 170, 171, 172, 173, 174, 175 and 176 are erected, and which is more particularly shaded in Plan 1.

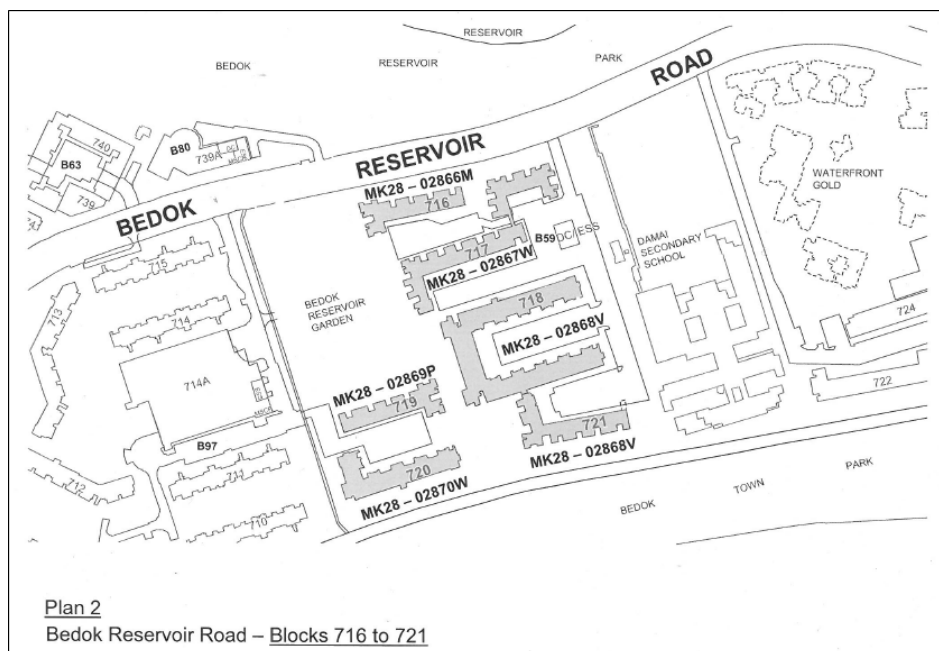
ANG MO KIO AVENUE 4



2. All that part of the housing estate of the Board at Bedok Reservoir Road comprised in Lot numbers 02866M, 02867W, 02869P and 02870W in Mukim 28 and on which Apartment Blocks 716, 717, 719 and 720 are erected, and in Lot number 02868V in Mukim 28 and on which Apartment Blocks 718 and 721 are erected, and which is more particularly shaded in Plan 2.

All that part of the housing estate of the Board bounded by Jurong Town Hall Road, Jurong East Street 13, Jurong East Central and Boon Lay Way, comprised in Lot numbers 03768A, 03899V, 03898W, 06569K, 05898X, 03897M, 05697V, 03905L, 03770T, 03864L, 03771A, 03772K, 03773N, 06568A, 03774X and 03775L in Mukim 05 and on which Apartment Blocks 101, 102, 103, 104, 105, 106, 107, 108, 109, 110, 111, 112, 113, 114, 115 and 116 are erected, and which is more particularly shaded in Plan 3.
