The Minister for Finance has specified that the lands and buildings of the Economic Development Board described in the Schedule including all the assets, houses, rights, interests and privileges as well as the debts, liabilities and obligations in connection therewith or appertaining thereto shall, with effect from 1st June 1968, be deemed to have been transferred to and vested in the Jurong Town Corporation.

THE SCHEDULE

1. JURONG TOWN

All that piece of land together with buildings and other property, movable or immovable thereon, in Mukim VI (Peng Kang), Mukim VII (Tuas), Mukim V (Pandan) and Mukim IX (Chua Chu Kang),

including the islands of Pulau Samulun and Pulau Damar Laut, comprising an area of 23,067,082 square metres or thereabouts, more particularly shown edged in red on plan 66/FT/75 and bounded approximately as follows:

And all that piece of land together with buildings and other property, movable or immovable thereon, in Mukim V (Pandan) comprising an area of 271,139 square metres or thereabouts bounded approximately as follows:

Commencing from a point on the intersection of the railway bridge and the east bank of Jurong River, the boundary runs southwards along the east bank of the river to meet the northern road reserve boundary of West Coast Road; thence eastwards along the aforesaid road reserve boundary for a distance of 439 metres; thence northwards at approximately a right angle to the said road for a distance of 317 metres; thence at approximately a right angle and eastwards for a distance of 171 metres; thence northwards along the western boundary of lands held under Permit Holdings No. 141 and 142 to meet the southern boundary of the railway line reserve; thence westwards along this railway line reserve boundary to the point of commencement.

3. ISLANDS

The islands in the waters of the Republic of Singapore together with buildings and other property, movable or immovable thereon, situate on the south of the Republic of Singapore known as Pulau Merlimau and Pulau Ayer Chawan comprised in Mukim No. XXXIV (other islands).

4. LANDS AT KALLANG BASIN

(i) *Plots A and B.*

All that piece of land comprising part of Lots 188¹, 188², 189⁴ and 191⁹ Town Subdivision No. 17, Kallang Basin, together with two blocks of flatted factory buildings and each situated on areas of 5,294 square metres and 5,393 square metres or thereabouts, at the junction of Boon Keng Road and Kallang Bahru, and more particularly shown edged in red as Plots A and B respectively on Plan 68/DT/105.

(ii) Plot C.

All that piece of land comprising part of Lots 190, 191⁹, 204²⁰ in Town Subdivision No. 17, Kallang Basin, together with 3 blocks of flatted factory buildings situated on an area of approximately 33,913 square metres or thereabouts, bounded by Bendemeer Road to the north, Kallang Tengah to the east, Kallang Bahru to the south and Boon Keng Road to the west and more particularly shown edged in red as Plot C on Plan 68/DT/105.
