## **Vocational and Industrial Training Board Bill**

#### Bill No. 4/1979

Read the first time on 10th January 1979.

An Act to establish the Vocational and Industrial Training Board and for matters connected therewith and to repeal the Lembaga Gerakan Pelajaran Dewasa Act (Chapter 177 of the Revised Edition) and the Industrial Training Board Act, 1972 (No. 36 of 1972), and to amend the Education Act (Chapter 175 of the Revised Edition).

Be it enacted by the President with the advice and consent of the Parliament of Singapore, as follows:—

#### PART I

### **PRELIMINARY**

#### Short title and commencement

- **1.**—(1) This Act may be cited as the Vocational and Industrial Training Board Act, 1979, and shall come into operation on such date as the Minister may, by notification in the *Gazette*, appoint.
  - (2) The Minister may appoint different dates for the coming into operation of the
