**ALLIED HEALTH PROFESSIONS ACT
(CHAPTER 6B)**

**ALLIED HEALTH PROFESSIONS
(REGISTRATION AND PRACTISING CERTIFICATES)
(AMENDMENT NO. 2) REGULATIONS 2016**

In exercise of the powers conferred by section 75 of the Allied Health Professions Act, the Allied Health Professions Council, with the approval of the Minister for Health, makes the following Regulations:

Citation and commencement

1. These Regulations are the Allied Health Professions (Registration and Practising Certificates) (Amendment No. 2) Regulations 2016 and come into operation on 1 June 2016.
