**ROAD TRAFFIC ACT
(CHAPTER 276)**

**ROAD TRAFFIC
(ELECTRONIC ROAD PRICING SYSTEM)
(AMENDMENT NO. 3) RULES 2015**

In exercise of the powers conferred by sections 34D and 140(1) of the Road Traffic Act, the Minister for Transport makes the following Rules:

Citation and commencement

1. These Rules may be cited as the Road Traffic (Electronic Road Pricing System) (Amendment No. 3) Rules 2015 and come into operation on 4 May 2015.

Amendment of First Schedule

2. The First Schedule to the Road Traffic (Electronic Road Pricing System) Rules 2015 (G.N. No. S 226/2015) is amended —

(a) by deleting Division 2 of Part 2 and substituting the following Division:
