ROAD TRAFFIC (ELECTRONIC ROAD PRICING SYSTEM) (AMENDMENT NO. 5) RULES 2015

In exercise of the powers conferred by sections 34D and 140(1) of the Road Traffic Act, the Minister for Transport makes the following Rules:

Citation and commencement

1. These Rules may be cited as the Road Traffic (Electronic Road Pricing System) (Amendment No. 5) Rules 2015 and come into operation on 2 November 2015.

Amendment of Part 2 of First Schedule

2. Part 2 of the First Schedule to the Road Traffic (Electronic Road Pricing System) Rules 2015 (G.N. No. S 226/2015) is amended by deleting Table IV in Division 2 and substituting the following Tables:
