**ROAD TRAFFIC ACT
(CHAPTER 276)**

**ROAD TRAFFIC
(ELECTRONIC ROAD PRICING SYSTEM)
(AMENDMENT NO. 5) RULES 2015**

In exercise of the powers conferred by sections 34D and 140(1) of the Road Traffic Act, the Minister for Transport makes the following Rules:

Citation and commencement

1. These Rules may be cited as the Road Traffic (Electronic Road Pricing System) (Amendment No. 5) Rules 2015 and come into operation on 2 November 2015.

Amendment of Part 2 of First Schedule

2. Part 2 of the First Schedule to the Road Traffic (Electronic Road Pricing System) Rules 2015 (G.N. No. S 226/2015) is amended by deleting Table IV in Division 2 and substituting the following Tables:

(Charges from 5.30 p.m. but before 6.25 p.m.)

Amount of road-user charge payable on any day from Monday to Friday from 5.30 p.m. but before 6.25 p.m., not being a public holiday or the eve of the New Year, Lunar New Year, Hari Raya Puasa, Deepavali or Christmas.
