# ROAD TRAFFIC (ELECTRONIC ROAD PRICING SYSTEM) (AMENDMENT NO. 2) RULES 2011

In exercise of the powers conferred by sections 34D and 140 of the Road Traffic Act, the Minister for Transport hereby makes the following Rules:

## Citation and commencement

1. These Rules may be cited as the Road Traffic (Electronic Road Pricing System) (Amendment No. 2) Rules 2011 and shall come into operation on 19th October 2011.

### **Amendment of First Schedule**

- **2.** The First Schedule to the Road Traffic (Electronic Road Pricing System) Rules 2011 (G.N. No. S 97/2011) is amended
  - (a) by deleting Division 2 of Part 19 and substituting the following Division:

#### "Division 2

#### **CHARGES**

Amount of road-user charge payable on any day from Monday to Friday, not being a public holiday or the eve of the New Year, Lunar New Year, Hari Raya Puasa, Deepavali or Christmas.
