DANGEROUS FIREWORKS (EXEMPTION) (NO. 8) NOTIFICATION 2010

In exercise of the powers conferred by section 9 of the Dangerous Fireworks Act, the Minister for Home Affairs hereby makes the following Notification:

Citation

1. This Notification may be cited as the Dangerous Fireworks (Exemption) (No. 8) Notification 2010.

Exemption

2. Section 3 of the Act shall not apply in respect of dangerous fireworks used in a fireworks display executed by Effects Technologies Pte Ltd (referred to in this Notification as the exempted person) for or on behalf of any person at the event specified in Part I of the Schedule in accordance with the conditions specified in Part II thereof.
