**ROAD TRAFFIC (PRESCRIBED OFFENCES AND PRESCRIBED NOTICES)  
(AMENDMENT NO. 2) RULES 2010**

In exercise of the powers conferred by sections 132, 134 and 140 of the Road Traffic Act, the Minister for Transport hereby makes the following Rules:

**Citation and commencement**

**1.** These Rules may be cited as the Road Traffic (Prescribed Offences and Prescribed Notices) (Amendment No. 2) Rules 2010 and shall come into operation on 1st November 2010.

**Amendment of rule 3**

**2.** Rule 3 of the Road Traffic (Prescribed Offences and Prescribed Notices) Rules (R 28) (referred to in these Rules as the principal Rules) is amended by deleting “A,” “G,”

and “, L”.

### **Amendment of First Schedule**

3. The First Schedule to the principal Rules is amended by deleting the words “section 120(1)(b)” in the first column of items 1, 2 and 3 and substituting in each case the words “section 120(3)”.

### **Amendment of Second Schedule**

4. The Second Schedule to the principal Rules is amended —
- (a) by deleting Form B and substituting the following Form:
