
Declaration of precincts for lift upgrading works

2. The parts of the housing estates of the Board described in the Schedule are hereby declared to be precincts for the purpose of carrying out lift upgrading works.

1. All that part of the housing estate of the Board at Ang Mo Kio Avenue 5 comprised in Lot number 7635T in Mukim 18 and on which Apartment Block 501 is erected, and which is more particularly delineated in Plan 1.


PLAN 1 ANG MO KIO AVENUE 5


PLAN 2 BEDOK RESERVOIR ROAD
