ROAD TRAFFIC (ELECTRONIC ROAD PRICING SYSTEM) (AMENDMENT NO. 3) RULES 2009

In exercise of the powers conferred by sections 34D and 140 of the Road Traffic Act, the Minister for Transport hereby makes the following Rules:

Citation and commencement

1. These Rules may be cited as the Road Traffic (Electronic Road Pricing System) (Amendment No. 3) Rules 2009 and shall come into operation on 4th May 2009.

Amendment of First Schedule

2. The First Schedule to the Road Traffic (Electronic Road Pricing System) Rules 2007 (G.N. No. S 738/2007) is amended by deleting all the items under the heading “CHARGES” in Part 6 and substituting the following items:
