ROAD TRAFFIC (ELECTRONIC ROAD PRICING SYSTEM) (AMENDMENT NO. 5) RULES 2008

In exercise of the powers conferred by sections 34D and 140 of the Road Traffic Act, the Minister for Transport hereby makes the following Rules:

Citation and commencement

1. These Rules may be cited as the Road Traffic (Electronic Road Pricing System) (Amendment No. 5) Rules 2008 and shall come into operation on 29th September 2008.

Amendment of First Schedule

2. The First Schedule to the Road Traffic (Electronic Road Pricing System) Rules (G.N. No. S 738/2007) is amended —

- (a) by deleting Part 11 and Part 28;
- (b) by deleting Part 15 and substituting the following Part:

“PART 15 — *CENTRAL BUSINESS DISTRICT*”

(A) *BUGIS-MARINA CENTRE CORDON
(EXCLUDING NICOLL HIGHWAY)*

SPECIFIED ROADS AND SPECIFIED ENTRY POINTS

<i>First column Specified roads</i>	<i>Second column Specified entry points</i>
1. Beach Road	Between the junction of Beach Road and Rochor Road and the junction of Beach Road and Middle Road on Beach Road on the southbound carriageway.
2. Bencoolen Street	Between the junction of Bencoolen Street and Rochor Road and the junction of Bencoolen Street and Albert Street on Bencoolen Street.
3. Crawford Street	Between the junction of Crawford Street and Beach Road and the entrance into the Crawford Street underpass on Crawford Street on the southbound carriageway.
4. North Bridge Road	Between the junction of North Bridge Road and Rochor Road and the junction of North Bridge Road and Tan Quee Lan Street on North Bridge Road.
5. Queen Street	Between the junction of Queen Street and Rochor Road and the junction of Queen Street and Albert Street on Queen Street.
6. Republic Boulevard	On the slip road into Republic Boulevard from Ophir Road.
7. River Valley Road	Between the junction of River Valley Road and Clemenceau Avenue and the junction of River Valley Road and Clarke Quay on River Valley Road on the southbound carriageway.
8. Temasek Boulevard	On the slip road into Temasek Boulevard from Rochor Road.
9. Victoria Street	Between the junction of Victoria Street and Rochor Road and the junction of Victoria Street and Middle Road on Victoria Street on the southbound carriageway.
