### Citation and commencement

1. This Order may be cited as the Housing and Development (Precincts for Lift Upgrading Works) (No. 13) Order 2007 and shall come into operation on 21st September 2007.


### **Declaration of precincts for lift upgrading works**



All that part of the housing estate of the Board at Bedok North Road/Avenue 1/Avenue 2/Street 1 comprised in Lot numbers 1837T, 1836P, 1947X, 1948L, 1635X, 1634N, 1620N, 1619L, 1633K, 1631T, 1632A and 1630P in Mukim 28 and on which Apartment Blocks 416, 418, 419, 420, 421, 422, 423, 424, 425, 426, 427 and 428 are erected, and which is more particularly delineated in Plan 1.


## PLAN 2 BEDOK NORTH STREET 4

### PLAN 3


### BEDOK NORTH STREET 4/AVENUE 4
