IMMIGRATION ACT (CHAPTER 133)

IMMIGRATION (AMENDMENT NO. 3) REGULATIONS 2007

In exercise of the powers conferred by section 55(1) of the Immigration Act, the Minister for Home Affairs hereby makes the following Regulations:

Citation and commencement

1. These Regulations may be cited as the Immigration (Amendment No. 3) Regulations 2007 and shall come into operation on 1st July 2007.

Amendment of regulation 8

2. Regulation 8(1) of the Immigration Regulations (Rg 1) is amended —

- (a) by deleting sub-paragraphs (a), (h) and (i);
- (b) by inserting the word "and" at the end of sub-paragraph (f); and
- (c) by deleting the semi-colon at the end of sub-paragraph (g) and substituting a full-stop.

Deletion of regulations 9, 9A and 10

3. Regulations 9, 9A and 10 of the Immigration Regulations are deleted.

Amendment of regulation 11

- 4. Regulation 11 of the Immigration Regulations is amended
 - (a) by deleting paragraph (1) and substituting the following paragraph:

"(1) A dependent's pass may be issued to any person (not being a prohibited immigrant) who is the spouse or dependent child of the holder of a work pass issued under the Employment of Foreign Manpower Act (Cap. 91A), to enable the spouse or child to accompany or join the holder of the work pass and to remain with him in Singapore.".

(b) by deleting the words "employment pass, work permit pass" in paragraph(7) and substituting the words "work pass under the Employment of Foreign Manpower Act (Cap. 91A)"; and

(c) by deleting the words "the consent in writing of the Controller" in paragraph (9) and substituting the words "a letter of consent issued by the Controller of Work Passes under the Employment of Foreign Manpower Act.".

Amendment of regulation 12

5. Regulation 12 of the Immigration Regulations is amended —

- (a) by deleting the word "or" at the end of paragraph (1)(a);
- (b) by deleting the full-stop at the end of paragraph (1)(b) and substituting the word "; or";
- (c) by inserting, immediately after sub-paragraph (b) of paragraph (1), the following sub-paragraph:
 - "(c) for the purposes of seeking employment in Singapore.";
- (d) by deleting the words "he has the consent in writing of the Controller or is the holder of a valid work permit issued under the Employment of Foreign Workers Act (Cap. 91A)" in paragraph (7) and substituting the words "he is a holder of a valid work pass issued under the Employment of Foreign Manpower Act (Cap. 91A)";
- (e) by deleting the words "or (10)(b)" in paragraph (8A);
- (f) by deleting paragraph (9) and substituting the following paragraph:

"(9) Where a work pass under the Employment of Foreign Manpower Act (Cap. 91A) is issued to the holder of a visit pass, and the work pass is cancelled under that Act, the visit pass shall by operation of this paragraph cease to be valid on the cancellation of the work pass, and the holder of the visit pass shall not remain in Singapore thereafter unless he is otherwise entitled or authorised to remain in Singapore under the provisions of the Act or other provisions of these Regulations."; and

(g) by deleting paragraph (10).

Amendment of regulation 14

6. Regulation 14 of the Immigration Regulations is amended by deleting paragraph (1A) and substituting the following paragraph:

"(1A) Every student's pass issued under paragraph (1) shall be subject to the
