ROAD TRAFFIC (ELECTRONIC ROAD PRICING SYSTEM) (AMENDMENT NO. 6) RULES 2007

In exercise of the powers conferred by sections 34D and 140 of the Road Traffic Act, the Minister for Transport hereby makes the following Rules:

Citation and commencement

1. These Rules may be cited as the Road Traffic (Electronic Road Pricing System) (Amendment No. 6) Rules 2007 and shall come into operation on 5th November 2007.

Amendment of First Schedule

2. The First Schedule to the Road Traffic (Electronic Road Pricing System) Rules (R 38) is amended —

(a) by inserting, immediately after Part IA, the following Part:

“PART IB

EAST COAST PARKWAY 3

SPECIFIED ROADS AND SPECIFIED ENTRY POINTS

1. East Coast Parkway	Between the Ayer Rajah Expressway and Fort Road exit before the Rochor Road exit into the East Coast Parkway on the eastbound carriageway.
2. East Coast Parkway	Between the Ayer Rajah Expressway and Fort Road exit at the slip road of Ophir Road into the East Coast Parkway on the eastbound carriageway.

CHARGES

Amount of road user charge payable on any day from Monday to Friday, not being a public holiday or the eve of the New Year, Lunar New Year, Hari Raya Puasa, Deepavali or Christmas.
