#### **HOUSING AND DEVELOPMENT (PRECINCTS FOR LIFT UPGRADING WORKS) ORDER 2006**

In exercise of the powers conferred by section 65B(1) of the Housing and Development Act, the Minister for National Development, after consulting the Housing and Development Board, hereby makes the following Order:

#### **Citation and commencement**

**1.** This Order may be cited as the Housing and Development (Precincts for Lift Upgrading Works) Order 2006 and shall come into operation on 5th January 2006.

#### **Declaration of precincts for lift upgrading works**


**2.** The parts of the housing estate of the Board described in the Schedule are hereby declared to be precincts for the purpose of carrying out lift upgrading works.

### **THE SCHEDULE**

1. All that part of the housing estate of the Board at Bukit Batok East Avenue 4 comprised in Lot numbers 2410T, 2409K, 2411A and 2416C in Mukim 10 and on which Apartment Blocks 255, 256, 261 and 262 are erected, and which is more particularly delineated in Plan 1.

PLAN 1


BUKIT BATOK EAST AVENUE 4



2. All that part of the housing estate of the Board at Petir Road/Gangsa Road comprised in Lot number 394L PT in Mukim 14 and on which Apartment Blocks 141, 142, 143, 144, 145, 146, 147, 148, 149, 150 and 151 are erected, and which is more particularly delineated in Plan 2.

PLAN 2


PETIR ROAD/GANGSA ROAD

PLAN 3


JURONG WEST STREET 41
