## **ROAD TRAFFIC ACT (CHAPTER 276)**

### **RESTRICTION OF SPEED (ROADS) (AMENDMENT) NOTIFICATION 2006**

In exercise of the powers conferred by section 63(2) of the Road Traffic Act, the Minister for Home Affairs hereby makes the following Notification:

#### **Citation and commencement**

**1.** This Notification may be cited as the Restriction of Speed (Roads) (Amendment) Notification 2006 and shall come into operation on 6th January 2006.

#### **Amendment of First Schedule**

**2.** Part 1 of the First Schedule to the Restriction of Speed (Roads) (N 6) (referred to in this Notification as the principal Notification) is amended by deleting the item relating to “Kranji Road”.

## Amendment of Second Schedule

3. The Second Schedule to the principal Notification is amended —

- (a) by inserting, immediately below the item relating to “Bendemeer Road”, the following item:

“Benoi Road — that part of Benoi Road between Upper Jurong Road and Pioneer Road.”;

- (b) by inserting, immediately below the item relating to “Boundary Road”, the following item:

“Brickland Road — that part of Brickland Road from Choa Chu Kang Avenue 3 to Sungei Tengah Road.”;

- (c) by inserting, immediately below the item relating to “Buangkok Green”, the following items:

“Bukit Batok Avenue 1.

Bukit Batok East Avenue 2 — that part of Bukit Batok East Avenue 2 between Hillview Avenue and Bukit Batok East Avenue 6.

Bukit Batok East Avenue 3 — that part of Bukit Batok East Avenue 3 between Toh Tuck Avenue and Bukit Batok East Avenue 6.

Bukit Batok East Avenue 6.

Bukit Batok West Avenue 2.

Bukit Panjang Road.”;

- (d) by inserting, immediately below the item relating to “Chin Swee Road”, the following items:

“Choa Chu Kang Avenue 3 — that part of Choa Chu Kang Avenue 3 between Choa Chu Kang Drive and Brickland Road.

Choa Chu Kang Drive — that part of Choa Chu Kang Drive between Choa Chu Kang Avenue 1 and Choa Chu Kang Crescent.”;

- (e) by deleting the item relating to “Choa Chu Kang Road” and substituting the following items:

“Choa Chu Kang Road.

Choa Chu Kang Way.”;

- (f) by deleting the item relating to “Clementi Avenue 6” and substituting the following item:

“Clementi Avenue 2.”;

- (g) by inserting, immediately below the item relating to “Commonwealth Avenue”, the following items:

“Commonwealth Avenue West — that part of Commonwealth Avenue West between Clementi Road and Clementi Service Road.

Corporation Road — that part of Corporation Road between Jurong West Avenue 2 and Jurong Port Road.”;

- (h) by inserting, immediately below the item relating to “Hill Street”, the following item:

“Hillview Avenue — that part of Hillview Avenue between Hillview Road and Bukit Batok East Avenue 2.”;

- (i) by inserting, immediately below the item relating to “Hougang Avenue 3”, the following item:

“International Road.”;

- (j) by inserting, immediately below the item relating to “Irwell Bank Road”, the following item:

“Jalan Ahmad Ibrahim — that part of Jalan Ahmad Ibrahim —

“(a) between Corporation Road and Ayer Rajah Expressway, in the direction towards City; and

(b) between Ayer Rajah Expressway and Jurong Port Road, in the direction towards Tuas.”;

- (k) by deleting the item relating to “Jalan Buroh”;

- (l) by inserting, immediately below the item relating to “Jalan Eunos”, the following items:

“Jurong East Central — that part of Jurong East Central between Bukit Batok Avenue 1 and Boon Lay Way.

Jurong East Street 11.

Jurong Port Road.”;

- (m) by deleting the item relating to “Kranji Road” and substituting the following item:

“Kranji Road.”;

- (n) by inserting, immediately below the item relating to “North Buona Vista Road”, the following items:

“Old Chua Chu Kang Road — that part of Old Chua Chu Kang Road between Lim Chu Kang Road and Sungei Tengah Road.

Old Jurong Road.”;

- (o) by inserting, immediately below the item relating to “Pasir Ris Drive 12”, the following items:

“Penjuru Road.

Petir Road.

Pioneer Road — that part of Pioneer Road —

“(a) between Pioneer Road North and Tuas Road; and

(b) between Tuas West Road and Tuas West Drive.

Pioneer Road North.”;

- (p) by inserting, immediately below the item relating to “Still Road South”, the following items:

“Sungei Kadut Avenue.

Sungei Kadut Drive.

Sungei Kadut Street 1 — that part of Sungei Kadut Street 1 from Sungei Kadut Drive to Sungei Kadut Avenue.”;

- (q) by inserting, immediately below the item relating to “Sungei Road”, the following item:

“Sungei Tengah Road — that part of Sungei Tengah Road between
