## **ROAD TRAFFIC (ELECTRONIC ROAD PRICING SYSTEM) (AMENDMENT NO. 2) RULES 2005**

In exercise of the powers conferred by sections 34D and 140(1) of the Road Traffic Act, the Minister for Transport hereby makes the following Rules:

### **Citation and commencement**

**1.** These Rules may be cited as the Road Traffic (Electronic Road Pricing System) (Amendment No. 2) Rules 2005 and shall come into operation on 3rd May 2005.

### **Amendment of First Schedule**

**2.** The First Schedule to the Road Traffic (Electronic Road Pricing System) Rules (R 38) is amended —

- (a) by deleting all the items under the heading “CHARGES” in Part I and substituting the following items:

#### **CHARGES**

Amount of road user charge payable on any day from Monday to Friday, not being a public holiday.
