### **ROAD TRAFFIC (ELECTRONIC ROAD PRICING SYSTEM) (AMENDMENT NO. 2) RULES 2001**

In exercise of the powers conferred by sections 34D and 140(1) of the Road Traffic Act, the Minister for Communications and Information Technology hereby makes the following Rules:

#### **Citation and commencement**

1. These Rules may be cited as the Road Traffic (Electronic Road Pricing System) (Amendment No. 2) Rules 2001 and shall come into operation on 2nd April 2001.

#### **Amendment of First Schedule**

2. The First Schedule to the Road Traffic (Electronic Road Pricing System) Rules (R 38) is amended —

- (a) by deleting the words “EAST COAST PARKWAY” in the heading to Part I and substituting the words “EAST COAST PARKWAY 1”;
- (b) by deleting item 2 relating to East Coast Parkway under the heading “SPECIFIED ROADS AND SPECIFIED ENTRY POINTS” in Part I;

(c) by inserting, immediately after Part I, the following Part:

“PART IA

EAST COAST PARKWAY 2

SPECIFIED ROADS AND SPECIFIED ENTRY POINTS

East Coast Parkway	On the slip road from Ophir Road into the East Coast Parkway on the westbound carriageway.

CHARGES
