ROAD TRAFFIC (ELECTRONIC ROAD PRICING SYSTEM) (AMENDMENT NO. 4) RULES 2001

In exercise of the powers conferred by sections 34D and 140(1) of the Road Traffic Act, the Minister for Communications and Information Technology hereby makes the following Rules:

Citation and commencement

1. These Rules may be cited as the Road Traffic (Electronic Road Pricing System) (Amendment No. 4) Rules 2001 and shall come into operation on 25th June 2001.

Amendment of First Schedule

- **2.** The First Schedule to the Road Traffic (Electronic Road Pricing System) Rules (R 38) is amended
