ROAD TRAFFIC (ELECTRONIC ROAD PRICING SYSTEM) (AMENDMENT) RULES 2001

In exercise of the powers conferred by sections 34D and 140(1) of the Road Traffic Act, the Minister for Communications and Information Technology hereby makes the following Rules:

Citation and commencement

1. These Rules may be cited as the Road Traffic (Electronic Road Pricing System) (Amendment) Rules 2001 and shall come into operation on 2nd January 2001.

Amendment of First Schedule

2. The First Schedule to the Road Traffic (Electronic Road Pricing System) Rules (R 38) is amended —

- (a) by deleting all the items under the heading “CHARGES” in Part I and substituting the following items:

CHARGES

Amount of road user charge payable on any day from Monday to Friday, not being a public holiday.

7. Buses registered in Singapore or elsewhere constructed for the carriage of not more than 30 passengers (excluding the driver)	\$1.70	\$2.25	\$0.60

8. Buses registered in Singapore or elsewhere constructed for the carriage of more than 30 passengers (excluding the driver) \$2.25 \$3.00 \$0.75.

- (b) by deleting all the items under the heading “CHARGES” in Part V and substituting the following items:

CHARGES

Amount of road user charge payable on any day from Monday to Friday, not being a public holiday except where such day falls on the eve of the New Year, Lunar New Year, Hari Raya Puasa, Deepavali and Christmas, the restricted hours shall cease at 1 p.m.
