### **PARKING PLACES (URBAN REDEVELOPMENT AUTHORITY) (AMENDMENT NO. 3) ORDER 1998**

In exercise of the powers conferred by sections 4 and 9 of the Parking Places Act, the Minister for Communications hereby makes the following Order:

#### **Citation and commencement**

**1.** This Order may be cited as the Parking Places (Urban Redevelopment Authority) (Amendment No. 3) Order 1998 and shall come into operation on 1st July 1998.
