## EDUCATION ENDOWMENT SCHEME ACT (CHAPTER 87A)

## EDUCATION ENDOWMENT SCHEME (EDUSAVE MERIT BURSARIES) (AMENDMENT) REGULATIONS 1997

In exercise of the powers conferred by sections 6(1)(d) and 24(a) of the Education Endowment Scheme Act, the Minister for Education hereby makes the following Regulations:

#### Citation and commencement

1. These Regulations may be cited as the Education Endowment Scheme (Edusave Merit Bursaries) (Amendment) Regulations 1997 and shall be deemed to have come into operation on 1st November 1996.

#### **Amendment of regulation 5**

2. Regulation 5 of the Education Endowment Scheme (Edusave Merit Bursaries) Regulations (Rg 5) (referred to in these Regulations as the principal Regulations) is amended —

- (a) by deleting the word "and" at the end of paragraph (1)(c)(ii);
- (b) by deleting sub-paragraph (iii) of paragraph (1)(c) and substituting the following sub-paragraphs:
  - "(iii) he is not in that year the recipient of any scholarship or award, established under the Education Endowment Scheme (Edusave Scholarships) Regulations (Rg 2) or the Education Endowment Scheme (Good Progress Awards) Regulations 1997 (G.N. No. S 485/97); and
  - (iv) he is not in that year enrolled in the Gifted Education Programme, the Music Elective Programme or the Art Elective Programme in an independent school.";
- (c) by inserting, immediately after the word "colleges" in paragraph (1)(d)(iii), the words "or the Good Progress Award established under the Education Endowment Scheme (Good Progress Awards) Regulations 1997 (G.N. No. S 485/97)"; and
- (d) by inserting, immediately after the word "thereof" at the end of paragraph (1)(e)(iii), the following words "or the Good Progress Award established under the Education Endowment Scheme (Good Progress Awards) Regulations 1997 (G.N. No. S 485/97)".

#### Deletion and substitution of regulation 9

**3.** Regulation 9 of the principal Regulations is deleted and the following regulation substituted therefor:

### "Application of Fund to assist pupils under the Community Education Award Scheme

- 9.—(1) Subject to paragraph (3), where the Citizens' Consultative Committee of any constituency or division of a group representation constituency has established a bursary for the purpose of providing financial assistance to pupils who—
  - (a) reside in that constituency or division;
  - (b) are in need of financial assistance for their education; and
  - (c) do not qualify for the Edusave Merit Bursary, the Good Progress
