

NOTICE 57 OF 2010

AMENDMENT NOTICE IN TERMS OF THE RESTITUTION OF LAND RIGHTS ACT, 1994 (ACT NO. 22 OF 1994), AS AMENDED

Notice is hereby given in terms of the proviso to section 11A(4) of the Restitution of Land Rights Act, Act No. 22 of 1994, as amended, that, with effect from the date of this notice, General Notice No. 911 of 2008 contained in Government Gazette No. 31287 dated 1 August 2008 ("the notice of 1 August 2008") is amended by –

1. deleting the letters "R/E" in the reference to the Farm Blyderivierpoort 416 KT;
2. in relation to Portion 8 of the Farm Berlin 209 KT, deleting the title deed number and substituting for it "T 39426/1967";
3. in relation to Portion 9 of the Farm Berlin 209 KT, deleting the title deed number and substituting for it "T 23724/1967";
4. in relation to Remaining Extent of Portion 10 of the Farm Berlin 209 KT, deleting the title deed number and substituting for it "T 43200/2003";
5. in relation to Remaining Extent of the Farm Middlesex 205 KT, deleting the title deed number and substituting for it "T 53575/1984";
6. deleting the reference to the farm "Leemington 207 KT (Vienna 207 KT)" and the property details relating thereto and substituting for it the references below to the farms "Leamington 207 KU" and the various portions of "Vienna 207 KT";
7. deleting the reference to "Venice 40 KT" and substituting "Venice 40 KU";
8. deleting the references to "Caskets" and substituting for them "Casketts";
9. deleting the reference to Portion 15 of the Farm Epsom 189 KT and substituting for it the reference to the Remaining Extent of Portion 15 of the Farm Epsom 189 KT in the table below;
10. deleting the reference to "Essem" and substituting for it "Esem";
11. deleting the reference to "Middelsex" and substituting for it "Middlesex";
12. deleting the reference to Remaining Extent of Hoofpyn 269 KT and substituting for it the references to the erven in the proclaimed township Kingfisher Hill Golf Estate listed in the table below;
13. deleting the reference to Portsmouth 215 KT and substituting for it the reference to Portsmouth 286 KT below;
14. inserting a new paragraph 1.5 as follows:

"1.5 L du Plessis on behalf of the Moletete-Blydepoort Community dated 22 July 1998."

15. inserting a new paragraph 1A after paragraph 1 as follows:

"Notice is given further that -

- (a) the simultaneous publication of the claims in the notice of 1 August 2008 is not intended to bring about the consolidation of the claims.;
- (b) in respect of the portions of the following farms referred to below or in the notice of 1 August 2008, the claimants referred to in the notice of 1 August 2008 do not seek restoration, but equitable redress:
 - (i) portions 2, 7, 11, 17, 22 to 29 and 34 to 36 of Berlin 209KT;
 - (ii) Portions 1 to 156 of Blyde Wildlife Estate 619 KT;
 - (iii) all portions of Happyland 241KT except Remaining Extent of Portion 2;"
