Made by the Lord Chief Justice under Section 9 of the Court of Appeal Act

Commencement [28th August, 1990]

ORDER 1 : CITATION

These rules may be cited as the Court of Appeal Rules.

ORDER 2 : APPLICATION

Rule 1. Application of Rules

Subject to rule 2 of this order, these Rules shall apply to all proceedings before the Court of Appeal.

Rule 2. Application of English rules

Where there is no provision in these Rules the rules of procedure for the time being in England relating to appeals to the Court of Appeal shall apply.
