## WASTE MANAGEMENT ACT

# AN ACT TO PROVIDE FOR THE COLLECTION AND DISPOSAL OF SOLID WASTES AND THE MANAGEMENT OF ALL WASTES IN THE KINGDOM<sup>1</sup>

Commencement [10th January, 2006]

### PART I - PRELIMINARY

#### 1 Short title

This Act may be cited as the Waste Management Act.

### 2 Interpretation

In this Act, unless the context otherwise requires —

### "approved Authority" means —

- (a) in relation to the Tongatapu waste management service area, the Waste Authority Limited;<sup>2</sup> and
- (b) in relation to other waste management service areas, the Ministry of Health or other entity appointed in accordance with section 5(3);
- "Authority" means the Waste Authority Limited;<sup>3</sup>
- "Board" means the Board of an approved Authority;
