

FISHERIES**Definitions of Mouths of Rivers**

ORDER, DATED 19TH OCTOBER 1973, MADE BY THE MINISTRY OF AGRICULTURE UNDER SECTION 16 OF THE FISHERIES ACT (NORTHERN IRELAND) 1966.

The Ministry of Agriculture on behalf of the Secretary of State in exercise of the powers conferred on it by section 16 of the Fisheries Act (Northern Ireland) 1966(a) and of all other powers enabling it in that behalf hereby makes the following Order:—

1. This Order may be cited as the Definitions of Mouths of Rivers Order (Northern Ireland) 1973.

2. The mouth of the Kilkeel River flowing into the Irish Sea is hereby defined to be an imaginary straight line running from the most southerly point of Meeney's Pier to the most easterly point of South Pier.

3. The mouth of the Comber River flowing into Strangford Lough is hereby defined to be a straight line marked A on the map in Schedule 1 to this Order, running from the point marked B on the said map to the point marked C on the said map. The said map is a section of Ordnance Survey map Down 10.

4. The mouth of Cross Hill Burn flowing into Strangford Lough is hereby defined to be a straight line marked D on the map in Schedule 2 to this Order, running from the point marked E on the said map to the point marked F on the said map. The said map is a section of Ordnance Survey map Down 10.

5. The mouth of the Termon River and the Waterfoot River flowing into Lower Lough Erne is hereby defined to be a straight line marked G on the map in Schedule 3 to this Order, running from the point marked H on the said map to the point marked I on the said map. The said map is a section of Ordnance Survey map 153.

6. The mouth of the Garvary River flowing into Lower Lough Erne is hereby defined to be a straight line marked J on the map in Schedule 4 to this Order, running from the point marked K on the said map to the point marked L on the said map. The said map is a section of Ordnance Survey maps Fermanagh 4 and Fermanagh 9.

7. The mouth of the Ballycassidy River flowing into Lower Lough Erne is hereby defined to be a straight line marked M on the map in Schedule 5 to this Order, running from the point marked N on the said map to the point marked O on the said map. The said map is a section of Ordnance Survey map Fermanagh 16.

8. The mouth of the Bannagh River flowing into Lower Lough Erne is hereby defined to be a straight line marked P on the map in Schedule 6 to this Order, running from the point marked Q on the said map to the point marked R on the said map. The said map is a section of Ordnance Survey map 153.

9. The mouth of the Kesh River flowing into Lower Lough Erne is hereby defined to be a straight line marked S on the map in Schedule 7 to this Order, running from the point marked T on the said map to the point marked U on the said map. The said map is a section of Ordnance Survey maps 153 and 154.

10. The mouth of the Dunmany or Colebrooke River flowing into Upper Lough Erne is hereby defined to be a straight line marked V on the map in Schedule 8 to this Order, running from the point marked W on the said map to the point marked X on the said map. The said map is a section of Ordnance Survey map 245.

11. The mouth of the Cladagh or Swanlinbar River flowing into Upper Lough Erne is hereby defined to be a straight line marked A1 on the map in Schedule 9 to this Order, running from the point marked B1 on the said map to the point marked C1 on the said map. The said map is a section of Ordnance Survey maps 244 and 245.

12. The mouth of the Arney River flowing into Upper Lough Erne is hereby defined to be a straight line marked D1 on the map in Schedule 10 to this Order, running from the point E1 on the said map to the point marked F1 on the said map. The said map is a section of Ordnance Survey maps 229 and 244.

13. The mouth of the Sillees River flowing into Upper Lough Erne is hereby defined to be a straight line marked G1 on the map in Schedule 11 to this Order, running from the point H1 on the said map to the point I1 on the said map. The said map is a section of Ordnance Survey map Fermanagh 22.








