It was unfortunate that we could not reach an agreement on the outcome document. I believe that in future, discussions on an outcome document should start early enough to ensure effective engagement and inclusivity.

I believe we should not let the challenges we experienced towards the closure of the meeting detract from our achievements.

We commend the secretariat for the commitment to their work and for ensuring adequate technical support throughout the sessions.

Madam Chairperson, we also thank you for your able stewardship.

I am convinced that the lessons we learn from our experiences will be critical to our future success at UNEA-3.

We should continue to build on UNEAs achievements.

Finally Madam Chairperson, I reaffirm my delegations continued committment to working closely with other Member States to ensure UNEP delivers on its mandate.
